DISD HIGH SCHOOL VARSITY DRILL TEAM AND DFDC CONSTITUTION

PURPOSE

The purpose of the Varsity Eaglettes drill team and the JV Eaglettes is to promote spirit and sportsmanship at school functions and to serve as a performing group representing the high school throughout the community, state, and nation. Instructional and performance activities are affirmatively directed toward development of individual member improvement, resulting in a highly skilled performance group. Each student selected must be cognizant of the time commitment and individual dedication demanded in striving for personal improvement and teamwork through responsibility and discipline. Students are exposed to teaching, practice, and performance opportunities that result in the development of responsibility, self-respect, and that encourages honest effort in striving for excellence. These opportunities also develop character, teamwork, and pride in quality performance and physical fitness by emphasizing the maintenance of high standards.

DEFINITION

Drill Team Year: The rules and procedures outlined in this constitution are in effect from the time the student is selected to the Varsity Eaglettes Drill team and the JV Eaglettes until the tryout for the next school year. This does not include the academic guidelines. Because of TEA rules, the academic policies are in effect for a school year.

SELECTION

All varsity drill team members will be required to try out for the team each year. Failure to participate in the tryout process will result in removal from the team.

The director will be responsible for the preparation and distribution of a packet of information to be made available to all candidates. This information will include specific tryout dates, times, attire, and procedures. This information must be approved by the building principal or designee prior to distribution. Candidates and parents must sign a form stating that they understand and will comply with all information in the packet before the students are allowed to participate in the tryout process. The DeSoto Independent School District will hold a centralized tryout for the selection of high school Varsity Eaglette drill team line members and JV Eaglette members. The goal of the centralized tryout will be to provide a consistent, equitable and monitored tryout process for all high school drill team candidates. The tryouts will be held on a Friday or Saturday in May to be determined by the principals and Director of Fine Arts. The date will not be during the week of six weeks and/or State-mandated testing. Every student wishing to audition must do so on this date with no exceptions. Any student who arrives at the tryout site after the tryouts for that campus have started will not be allowed to try out. There will be no application fees or tryout fees for students trying out for the varsity drill team or the JV Eaglettes.

The school district will bring in judges to assist in the selection process. There will be a three-five member judging panel that will score candidates from each school. Each candidate must score a minimum of 80 out of a possible 100 points in order to be placed on Varsity Eaglettes or 70-40 points to be placed on the JV Eaglettes. In order for a candidate to be placed on Varsity Eaglettes the candidate must also meet the two following requirements:

*Varsity Eaglette candidate MUST have a right leg split.

*Varsity Eaglette candidate MUST have a right double pirouette.

Scores given to a student by an individual judge will not be changed by a director, principal, or the Director of Fine Arts.

Parents will not be allowed in the building during any phase of the tryouts.

The number of candidates selected each year will be based on the number of candidates who earn the mandatory 80 points from the judging panel. In order to try out, a student must be at least a freshman and meet all State, TEA, and DISD requirements.

Anyone transferring from one campus to another during the current year will forfeit his/her position on the team. If a student wishes to join the varsity drill team at the new school of attendance, that student must wait for the scheduled yearly tryout to audition.

Candidates selected to be a member of the Varsity Eaglettes or the JV Eaglettes line are expected to make a commitment to the activity for the full year. Any drill team member who voluntarily quits the team before the end of the school year will not be allowed to tryout at the next tryout session unless he/she has had prior approval from the principal and director. Candidates who voluntarily quit will not receive any refunds of payments that have been submitted to DeSoto High School. All payments are final.

Varsity drill team candidates are required to submit the pre-participation medical evaluation/medical history form prior to tryouts. If the candidate answers yes to the questions outlined on this form then the candidate must also complete the physical exam form. Once a candidate is selected as a member of the drill team, the member will be required to complete the physical form. ALL drill team members must complete this form each year. DeSoto ISD will offer low cost physicals through the athletic department during the month of May.

To be eligible for tryouts, students must have passed all subjects the preceding six-week grading period in order to participate in all of the out-of-school workshops and judging.

INJURY AND USE OF VIDEO

In the case of physical injury prior to the tryout, the Director of Fine Arts must be notified for permission to have any deviations in the tryout procedure.

A video can only be used after notification of the Director of Fine Arts, and only in the case of an injury that impairs a student from participating in a "specific skill" of the tryout. If a video is used, only a small segment of the video that shows the "specific skill" done by the student prior to the tryout may be judged.

A medical doctor's note indicating the specific skill the student is incapable of performing will be required prior to video use.

VIDEO USAGE GUIDELINES

Directors will make these guidelines available to judges if a video is used for tryout.

The judges shall be instructed to consider "absence of pressure," lack of physical/respiratory exertion, vocal ability, and note if a candidate is using a hard or spring floor when performing specific skills" on video.

The candidate must perform each individual "specific skill" required in the tryout to receive credit/points.

No score reduction or credit shall be exercised due to the claimed injury.

However, in light of the above considerations, a perfect score for any "specific skill" or category should be rare.

JUDGES

Judges will be selected from qualified professionals and can include directors from high school and/or college campuses. Outside judges should not be hired to judge tryouts if they have tutored or taught the drill team candidates during the current school year. Every attempt should be made to hire outside judges who have not worked with students in the DeSoto area. However, with the hundreds of camps in the state of Texas, attended by thousands of drill team members and taught by hundreds of instructors, it may be possible at some time that a member of the judging panel may have had some contact with a candidate who is trying out.

Professional judges with outstanding credential and references will be hired for all tryouts. They will be instructed to judge the candidates based only on the mastery of the skills that they see demonstrated during the tryouts. Tryout results will not be challenged because of prior knowledge of judges and candidates.

TRYOUTS

Tryouts will be closed to everyone except judges, directors, principals, and principals' designees. There will be no students, parents, or existing drill team members who are not part of the audition in the tryout room/area, nor will they be involved in the collection or tabulation of scores.

Any deviation by the candidates from the tryout requirements may result in the disqualification of the candidate.

The Following Listed Are Tryouts/Requirements/Procedures:

- A. At the time of tryouts, a drill team candidate must currently be a resident of the attendance zone in which the school for which the student is trying out is located, or have an approved transfer from the office of school administration to attend that school for the next school year.
- B. Any student who plans to tryout for the team must be in the 8th, 9th, 10th, or 11th grade at the time of tryouts.
- C. All prospective members must attend and participate in tryouts. The director and administration will handle on an individual basis circumstances preventing a prospective member from participating.
- D. Each student shall be judged on the basis of dance ability and other related areas such as poise and projection and knowledge of routine.
- E. There will be a panel of qualified judges who will make the final decision. The score sheets used by the judges will be strictly confidential.
- F. An individual member's drill/dance team year begins on the day the member's name is officially posted/announcement of the new team and continues until that membership is officially terminated or announcement of the new team.
- G. If there is additional space available, a student new to the district may be given the opportunity to tryout.
- H. Prospective members and their parents must be fully aware of the expenses of dance/drill team as explained in the tryout general information. They must be willing to meet all financial obligations. If a student is not able to meet all financial obligations, the student needs to consult the director.
- I. Current members of the dance/drill team must tryout each year.
- J. Each member must be physically fit and capable of enduring strenuous activity. Therefore, an annual physical examination is required.
 - 1. Prospective members must have either a physical or a waiver releasing liability from the district prior to tryouts.
 - 2. Returning members, as well as new members, must have a physical examination completed and returned to the director before attending any summer camp. They have

the option of having physicals by their own doctors, or they may take advantage of a district physical scheduled prior to camp.

TABULATION OF SCORES

Each of the 3-5 judges will enter each candidate's scores into an Excel spreadsheet. At the conclusion of the tryouts, a technical assistant will download all of the judges' individual score sheets into a master database.

When the tryouts are completed, only the campus administrator and tabulation person will be allowed in the tabulation room. When all scores are reviewed and ranked, the drill team director and assistant director will be allowed in the room to review the totals. No one else will be in the tabulation room.

JUDGING CRITERIA FOR DRILL TEAM TRYOUTS

Overall Appearance (5)

Splits (Right leg split is a requirement to make Varsity)

Right Leg: (25)

Left Leg: (10)

Right Double Pirouette (Requirement to Make Varsity) (25)

Jazz Routine (25)

Kick Combination (10)

The highest possible score is 100 points. Candidates MUST score a minimum of 80 points to be selected for the varsity team.

ELIGIBILITY AND MAINTENANCE

In order to be eligible for any six-week period following the initial six-week period of a school year, a student shall not have a recorded grade average lower than 70 on a scale of 0-100 in any course for the preceding six-week period. To be eligible to participate in the six-week periods following the initial six-week period of a school year, a student must not have a recorded grade average lower than a 70 in any course for that preceding six-week period.

A student whose recorded six-week grade average in any course is lower than a 70 at the end of a six-week period shall be suspended from competition or performance. A suspension continues for at least three weeks and is not removed during the school year until the student is passing all subjects taken.

A student who regains eligibility at the end of a six-week or three-week grading period shall not become eligible until the end of the school day seven calendar days later.

Students on academic probation must continue to attend classes and all practices, must sit out of all performances, and may not sit with or ride with the team to appearances or performances. Students on probation are not allowed to wear the team pep rally or performance uniform. This stated policy does not apply to social activities.

A drill team member who becomes academically ineligible two times during a school year will be considered on drill team probation for the rest of that school year with regard to auditioning and performing with specialty groups.

A drill team member who becomes academically ineligible two times during a school year will be removed from the team.

Grade Requirements and Consequences Resulting from Infractions:

- A. All grade averages will be checked and recorded immediately after the close of each Grading period.
- B. Any member who makes an "F" in a grading period is ineligible for dance/drill team performance activities for the period of time defined by the "No Pass/No Play" guidelines from the state.
- C. An academic waiver for failure in an exempted course as defined by state law may be granted by the administration. A special education student may also obtain an academic waiver through the administration should the member fail a particular class through an IEP established at an ARD.
- D. Any member who receives two or more "F's" as a semester grade will be permanently removed.

CONDUCT

Standards of Conduct

- A. Members are expected to uphold a class/high standard of behavior that is necessary for the integrity and reputation of the organization. Members should be leaders in the school and should set a good example at all times. Members are expected to have and maintain a character/class above reproach.
- B. Proper manners should be used at all times to address adults and officers. Mutual respect and politeness toward fellow members within the group are basic elements that contribute to the total success of the team. Yes ma'am, No ma'am, and Thank you will be used at all times.
- C. The following are expressly forbidden: Fighting/assault or harassment of director or team members, theft of team or individual property. At the first infraction of either of these rules, the member will be removed from the team.
- D. The possession and/or use of alcohol, tobacco, and illegal drugs are expressly forbidden and will not be tolerated. At the first infraction of either of these rules, the student will be removed from the team.
- E. Drill team members will wear practice and performance uniforms as designated by the director.
- F. No unnatural hair color/visible tattoos or body piercings/spacers will be allowed during any drill team function/activity. Failure to abide by this policy will result in point deductions for insubordination.
- G. Maintaining a higher standard of conduct will also include ensuring that drill team members' websites and all social media are appropriate. The internet is a worldwide, publicly accessible form of communication. Any communication such as text message, Facebook, Snap Chat,

Twitter, Kik, Instagram and photo sharing, etc. appearing on the internet is public domain even if it is marked private. Drill team members are responsible for their personal websites and postings as well as for postings on other students' websites. The area of appropriateness will include, but are not limited to, language (abbreviated or alluding to), bullying, harassment, pictures, suggestive poses, clothing, reference to alcohol, drugs, and tobacco. Any question of appropriateness will be decided by the principal and director and will result in point accumulation or dismissal.

- H. Dance officers will find and friend all Eaglette line members. Members are required to accept their friend request or they will receive a point deduction. The Director and Dance Officers will monitor the girls' activity. Any profanity, unsportsmanlike/suggestive comments, or posts that would reflect poorly on the Eaglettes organization will asked to be removed immediately, and the member committing the offense will receive *permanent* point deductions.
- I. Any criminal activity by a member (i.e. fighting, drugs, stealing) of the drill team at a drill team/school function, whether on or off campus, at the first infraction of either of these rules, the student will be removed from the team.
- J. If the school administration deems that removal is not warranted, the drill team member will have points deducted based on the school discipline as outlined in the constitution. (Suspension, ISS, DAEP).

Maintaining Membership

Each member is expected to abide by all rules and regulations set forth by the constitution and by the director.

PROBATION AND REMOVAL

A. Probation—Academic

A drill team member may be placed on academic probation for academic/citizenship reasons as stated in the TEA/DISD policies. If a member is placed on academic probation, that member will also be on probation regarding the specialty groups and may not audition for or perform with such groups for the remainder of the academic probation term. Students who are placed on academic probation twice in one year will automatically be on probation with regard to specialty groups for the remainder of the school year.

B. Probation—Disciplinary

A drill team member may be placed on disciplinary probation for indicated periods of time as described in the Regulations/Policies and Attendance sections of this document.

A drill team member on disciplinary/financial probation will not be allowed to participate in auditions or performances of the team, or of specialty groups, as defined in the specialty groups section of this constitution.

A drill team member on disciplinary/financial probation will not be allowed to travel with the team for any reason. The member will not be allowed to wear the uniform. During the probationary period, the student must attend classes, work periods and practices as scheduled during and before/after school hours.

C. Removal

A drill team member may be removed from the drill team or placed on disciplinary probation by the drill team director and principal for violation of the Standards of Conduct or Regulations and Policies sections of this constitution.

Removal occurs once point deductions reach 22 or more. If the student progresses to 22 or more points without having served other disciplinary actions, or during a disciplinary term, removal is still the result, and will be immediate.

If a member of the team suffers loss of credit for the drill team course for excessive absences, he/she may be removed from the team subject to principal/director review.

A drill team member who is placed in the ISS room more than twice time during the drill team year will be subject to a principal/director review which may result in removal from the squad.

A drill team member who is placed in the alternative school will be removed from the team immediately, effective on the date of placement.

A drill team member who is suspended from school will have a principal/director/parent/student review and may be removed from the team.

A drill team member who is expelled from school will be removed from the team.

If a drill team member misses more than two (2) practices in one week during football season, he/she will be benched from that week's performance.

If a drill team member misses band run through during football season, he/she will be benched from that week's performance.

If a drill team member misses more than three (3) practices during contest season, he/she may be removed from one or more contest performances.

Jobs, vacations, college visits, outside dancing/cheering etc. are not to interfere with practices, performances and scheduled events. The member should submit practice and game schedules to employers so that work schedules can be made around practice and performance schedules.

Work is not an excuse to leave practice or a performance early or arrive late.

Members are required to attend tutorials weekly during the time designated by the director/sponsor/coach. Tutoring is not to interfere with practice times.

Students who have been removed and those who voluntarily quit retain no rights to team awards, recognitions, etc., which are received after dismissal, although they may have accrued over the duration of the school term. There will be no refunds given if a student is removed or voluntarily quits or is removed from the team. They lose all privileges associated with varsity drill team membership, including attending drill team-only events, using drill team facilities, letter jackets, and wearing drill team attire.

Any student removed from the drill team must also be removed from the class.

A drill team member who has been removed from the squad will not be eligible to participate in the next tryouts without approval from the principal and director. Areas to be reviewed will include but not be limited to the reasons for the referrals, academic grades, other discipline records, student attitude, and any other factors deemed relevant by the principal and director.

REGULATIONS AND POLICIES

The following are considered rule infractions. Point deductions for each are indicated. Points are strictly used only to determine disciplinary probation periods and are not used for grading purposes. Points are deducted for one school year, and at the beginning at the next school year, each member's record is cleared.

<u>Probation:</u> Member is not allowed to participate in auditions or performances of the team or of specialty groups. The member is not allowed to travel with the team for any reason. Member may not wear the drill team uniform. Member must continue to attend classes, work periods, and practices as scheduled during and before/after school hours.

Point Deduction System

If a student in academically ineligible at the time of a disciplinary probation, the penalty will be served at the time that the student regains eligibility.

-5 points	1 week Probation
-10 points	2 week Probation
-15 points	3 week Probation
-20 points	4 week Probation
-21 points	6 week Probation

A student will receive one week probation after the initial 5 points accrued and every 5 points thereafter a week of probation. The accumulation of 22 points will result in immediate removal even if no probationary periods have occurred.

Any officer or social officer who receives 5 points and is placed on one week probation will be removed from her officer position and placed on the line immediately. There is no exception to this rule.

MERITS

The director may choose to offer merits for services deemed appropriate. The rewards for such earned merits are also at the director's discretion. Each merit is earned at half the point of deduction. An example is below:

POINT DEDUCTION	NUMBER MERITS REQUIRED TO REGAIN POINTS
1	2 (two ½ point merits)
3	6 (six ½ point merits)

NOTE: Permanent point deductions cannot be absolved by merits. Those deductions will remain on the drill team member's record the duration of the school calendar year and will not be absolved until the week after auditions for the new line.

DRILL TEAM PRACTICE AND PERFORMANCES

- A. Drill team members must attend ALL practice sessions as determined by the director. Absence from practice may result in a missed performance if the director determines that the absence has hindered the ability of the team to practice productively.
- B. Activities and practice time must be in accordance with TEA guidelines. Practices must be limited to a total of eight hours per school week outside the school day. A school week is determined as from Monday 12:00 a.m. to the end of the school day on Friday.
- C. Students should use discretion in his/her commitments to multiple extracurricular activities.
- D. There will be tryouts for each performance. The director and assistant director will judge routines. Factors such as attitude, manners, and effort will be taken into consideration as well as ability. Students unable to execute the routine to the expected standard or who have exhibited excessive negativity regarding practices will not be chosen to perform.
- E. If a member is removed from the performance due to tryouts, absences, illness, or injury, that member must continue to attend practices and team performances in uniform unless the illness or injury prohibits him/her from doing so.
- F. A student may only perform if in correct and complete uniform at the time of performance.

ATTENDANCE:

Absences (these rules govern all practices, including those not during school hours)

- A. Attendance at all drill team activities and practices is **mandatory**.
- B. An absence is recorded if more than 15 minutes late.
- C. For every **3** tardies a member will receive an unexcused absence and will receive a 10-point deduction.

EXCUSED ABSENCES:

- 1. Personal illness or accident (members are required to come to practice and watch unless running a fever or vomiting).
- 2. Death in the family.
- 3. Religious holidays.
- 4. Special school UIL activity with advance notification and approval from the director/sponsor/coach.

UNEXCUSED ABSENCES:

- 1. Absences for reasons other than those listed above as excused will be classified as unexcused (this includes absences from membership only class).
- 2. Failure to report a possible excused absence will result in the absence being classified as unexcused.
- 3. Unexcused absences will result in the receipt of demerits/disciplinary action and may result in loss of performance eligibility, suspension or dismissal.

REPORTING OF ABSENCES

- A. In the event of an unexpected absence (illness, accident or death in the family) the member must notify the director/sponsor/coach of the absence and the reason for the absence prior to class/practice.
- B. It is the ultimate responsibility of the member to, but the parent/guardian of the member may, call the director/sponsor/coach and speak directly to or leave a message on the director/sponsor/coach's school voicemail or email.
- C. Leaving a message with another member is not sufficient or an accepted form of notification.
- D. An unexcused absence from drill team class periods and other practices receives a 10-point deduction.
- E. Two or more absences from practice will result in student being benched from the next performance. Frequent absences hinder the ability of the team to practice efficiently for that performance.
- F. If a member will be absent from practice it is mandatory that communication be made to the director no fewer than 2 hours prior to the absence. This can be in written form (hand written note), a phone call or email from parent/guardian. Having other team members relay messages is not acceptable.

Notification of expected absences will require at least a 48 hr notice in order to be classified as excused.

Notification of unexpected absences will require notification within 12 hrs in order to be classified as excused.

HEALTH ISSUES

Members may not be exempt from practice for longer than 3 days without a note from a doctor. If the member does need to sit out of practice for medical reasons, they may not be eligible to perform.

FINANCIAL OBLIGATIONS

Because drill team is an extra-curricular activity, there are both financial and time commitments involved in being a part of a successful drill team. These commitments are spelled out clearly for each school in the packets that are distributed prior to tryouts. It is critical that students and parents understand the financial obligations of the organization and the timeline for submitting payments due for materials and/or activities before the student decides to try out for the team. All members will participate in up to three individual school sponsored fundraisers per year.

Any member who chooses to not participate in fundraising opportunities will be financially responsible for the designated fundraising amount out of pocket.

Any student who fails to make a payment on time will not be allowed to perform with the organization until such time that the financial obligation is satisfied.

Any student who fails to make three consecutive payments on time will be removed from Varsity Eaglettes or JV Eaglettes.

Any drill team member who has not met their financial obligation for the current school year will not be allowed to try out for the next school year.

INCLEMENT WEATHER

In the event of inclement weather, it will be the responsibility of the drill team director, in collaboration with the building principal, to make the decision to leave the event. The decision will be based on what is in the best interests of the students and their health and welfare. If a parent or student voluntarily leaves a drill team event, they will be subject to the penalties as outlined in the drill team constitution.

TRANSPORTATION TO AND FROM PERFORMANCES

For performances that require the team to travel on a school bus or chartered bus, members are required to ride the bus with the group to AND from the venue.

Members are not permitted to ride home with anyone but a parent or legal guardian from a performance event. A written request must be submitted at least 24 hours in advance for members to arrange alternate transportation with a parent or legal guardian.

Members are expected to be picked up from practices and performances in a timely manner. Any member who fails to arrange transportation to arrive and pick them up within 20 minutes of the arrival to the destination may lose points or be benched from the following performance.

SPECIALTY GROUPS

- A. It is up to the discretion of the director to decide whether to offer specialty groups such as elite dance teams and kick lines.
- B. Any member is eligible to audition for specialty groups such as: Diva Squad, Kick lines, Elite dance teams, Contest teams, Officers, Social Officers, etc., unless on academic or disciplinary probation.
- C. Specialty groups are: Officers, Social Officers, Diva Squad, Kick lines, Elite dance teams, Contest teams, Travel teams, and other special groups. It is considered a privilege to be a part of these specialty groups.

LETTERMAN JACKETS

In order to receive a letterman jacket you must have fully completed two spring shows as a Varsity member.

Academic Probation:

Fail a course:

- ✓ Ineligible to perform, travel, or wear uniforms until eligibility is regained.
- ✓ Also may not perform with or audition for specialty groups until eligibility is regained.

Fail twice in one school year:

✓ May not perform with or audition for specialty groups for the remainder of the school year.

Fail three times in one school year:

✓ Removal

Disciplinary Benching/Probation:

- ✓ Accumulation of 5 points: 1 week probation
- ✓ Accumulation of 10 points: 2 week probation
- ✓ Accumulation of 15 points: 3 week probation
- ✓ Accumulation of 20 points: 4 week probation
- ✓ Accumulation of 21 points: 6 week probation
- ✓ Accumulation of 22 points: removal

Removal:

Any of the following will result in removal:

• Third academic failure in one school year • Assault or harassment of director or team members • Theft of individual or team property • Participation in illegal activities as determined by school code of conduct • Violating Standard of Conduct and/or Regulations and Policies of constitution • Accumulation of 22 points • ISS placement more than twice in a school year • Placement in Alternative School • Expulsion from school • Suspension from school • Missing more than 10 practices/performances in one term/semester • Loss of Credit for the drill team course due to excessive absences • Second infraction of tobacco, alcohol, illegal drug policy.
